**TERMS AND CONDITIONS OF CREDIT**

It is agreed that all purchases and all extensions of credit are made subject to the following terms and conditions:

1. The Purchaser (named on the first page hereof) agrees that all amounts due for goods and services purchased from Coca-Cola Bottling Company United, Incorporated (CCBCU, Inc. "you" or "your") are payable at: **PO Box 105637, Atlanta, GA 30348-5637.**
2. The Purchaser agrees to honor and satisfy all obligations to CCBCU, Inc. The Purchaser also agrees to pay CCBCU, Inc. a service charge of \$25.00 for each NSF and other check returned by Purchaser's bank.
3. The Purchaser agrees in the event the account becomes delinquent and is turned over for collection, to pay all costs of collection, including reasonable attorney fees, court costs, repossession fees and collection agency fees.
4. The Purchaser agrees to notify CCBCU, Inc. by certified mail of any change in ownership of the Purchaser.
5. The Purchaser acknowledges that the goods and/or services purchased from CCBCU, Inc. are not payable in installments, but are payable in full within **21** days from date of invoice unless CCBCU, Inc. expressly provides different terms on the invoice.
6. If any amounts become past due, CCBCU, Inc., in addition to all other rights, may at its first option either refuse delivery to Purchaser or deliver to Purchaser on a C.O.D. basis only, and/or may require deposits to be nonrefundable.
7. The Purchaser understands and agrees that the granting of any credit to Purchaser hereunder and/or the amount or terms of such credit is in the sole exclusive discretion of CCBCU, Inc.
8. The Purchaser certifies that all information contained in this application is true and correct.
9. The Purchaser authorizes CCBCU, Inc. to make a credit investigation whereby information is obtained (1) through credit inquiries with provided references, if any, and (2) from others.
10. If the Purchaser is a corporation, partnership, LLC or other legal entity, the undersigned is authorized to make application and obligate said entity for any credit extended as a result of this application. Further, such entity will continue to be bound and obligated for any credit advanced until two business days after formal, written notice to the contrary is actually received at the office of CCBCU, Inc.'s chief financial officer.
11. In order not to be charged sales tax, Purchaser must provide CCBCU, Inc. with a sales tax exemption certificate. (Please attach.)
